**AN ORDINANCE OF THE ASSEMBLY OF THE KODIAK ISLAND BOROUGH AMENDING SECTION 2.30.060 ASSEMBLY ORDER OF BUSINESS AND AGENDA, ADDING A STATEMENT OF LAND ACKNOWLEDGEMENT.**

**WHEREAS,** The Assembly desires to add a recognition of the ancestral lands in the area as a regular part of its meetings following the invocation.

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KODIAK ISLAND BOROUGH** that:

**Section 1:** This ordinance is of a general and permanent nature and shall become a part of the Kodiak Island Borough Code of Ordinances.

**Section 2:** That Section 2.30.060, Order of business and agenda, of the Kodiak Island Borough Code of Ordinances is amended to read as follows:

**2.30.060 Order of business and agenda.**

A. Order of Business. The order of business for each regular meeting of the assembly shall be as follows:

1. Invocation.

2. Pledge of Allegiance.

**3. Statement of Land Acknowledgement.**
